#### **LIST OF DATES & SYNOPSIS**

The petitioner association is aggrieved from the action of the respondent no. 2 on behalf of its member schools where the respondent no. 2 vide orders dated 22.12.2017 (Annexure P-4) has declare the holidays for the students studying in the schools situated in the State of Haryana on the occasion of winter vacation w.e.f. 25.12.2017 till 08.01.2018. Effectively the schools have been closed from 23.12.2017. It will create the hurdles for the students to get their syllabus be completed on time, as well as, the unnecessary pressure on the management of the schools to not only to get the syllabus of the students be completed on time before start of the examination reason being the board examination for Class 10th and Class 12th is going to start in the month of February & March, 2018 till then the schools will not able to achieve the mandatory academic session of 220 days in a year. The respondent no. 2 has declared the winter vacation for the students for such a long period even where the season is very cosy and good thus, there is no occasion arises to close the school unnecessarily. The petitioner association on behalf of its member schools is before this Hon'ble court to get their schools be remained open as usual in the larger interest of the students.

The association has been registered at New Delhi by getting the certificate of registration from the concerned registration authorities as the society has been registered at New Delhi for the members schools situated in all over India.

Civil Writ Petition under Article 226/227 of the Constitution of India praying for the issuance of any writ, orders or directions especially in the nature of certiorari to quash the orders dated 22.12.2017 passed by the respondent no. 2 (Annexure P-4) vide which the respondent no. 2 ordered that all the schools situated in the State of Harvana will remain closed w.e.f. 25.12.2017 to 08.01.2018 (effectively the schools have already closed from 23.12.2017) on account of winter vacations as the orders passed by the respondent no. 2 is against the provision of Section 20 of the Haryana Education Rules, 2003 (Annexure P-5), as well as, the proviso 23 of the CBSE By-Laws (Annexure P-6); a writ of certiorari may kindly be issued to the respondents to set aside the orders dated 22.12.2017 (Annexure P-4) as there is no acute winter is there and season is very good and a long vacation spell could not only hampered the completion of the syllabus of the students, as well as, the schools will not able to complete their

mandatory academic session of 220 days in a year as per Section 20 of the Education Haryana Rules, 2003 (Annexure P-5); a writ of mandamus may kindly be issued to the respondents to allow the private un-aided schools to open their schools to complete their syllabus as very less time is available for completion of syllabus from Class 9th to Class 12th onwards reason being there is a board examination for Class 10th and Class 12th which will be start in the month of February and March, 2018 thus, the students will not able to complete their syllabus which will put effect upon their academic achievements; a writ of mandamus may kindly be issued to the respondents to grant the flexibility to the member schools of the petitioner association to close their schools as and when the acute winter starts and the school management will feel that the season is the impediment for creating the students in their smooth study thus, they will declare the holiday in their schools

with the prior approval of the respective DEOs/BEOs of the District

#### **RESPECTFULLY SHOWETH:**

- 1. That the members of the petitioner society are the citizens of India. The authorized signatory who is filing the present petition before this Hon'ble court is the citizen of India and the resident of the State of Haryana thus, fully competent to invoke the extraordinary writ jurisdiction of this Hon'ble court by way of filing the present writ petition under Article 226/227 of Constitution of India to get the orders passed by the respondent no. 2 without considering the betterment of the students.
- 2. That the petitioner society has been registered in the name of NISA Education on 26.10.2015 at New Delhi and the Registrar of Societies, South District, Government of NCT of Delhi has issued the certificate of registration under his seal and signature on 26.10.2015 by giving the legal sanctity to the society. Copy of the certificate dated 26.10.2015 is appended herewith as **Annexure P-1**.
- 3. That the society was registered having the aims and objectives to rake up the issues of the private schools so that the member schools of the society could carry out their functions without any problem apart from other aims and objectives for which the society was

established. The copy of the memorandum of association of society is appended herewith as **Annexure P-2**.

- 4. That the list of the member schools situated in the State of Haryana is also enclosed with this writ petition and the society is having 227 situated in the State of Haryana are its members on behalf of which the present petition is being filed. Copy of the list of the member schools are appended herewith as **Annexure P-3**.
- 5. That the petitioner society is having a sphere in all the states of country and its members are not only trying to smoothen the problems of the private schools so that the management of the member schools could concentrate on the betterment of the students studying in their schools. The other objective of the petitioner society is to uplift the down trodden members of the society so that their status could be uplifted with the light of education in the society with intention to prove them as an asset for the country.
- 6. That the respondent no. 2 has passed the orders on 22.12.2017 in which by exercising his powers under Rule 20 (2) of the Haryana School Education Rules, 2003 and the orders of the Government have closed the schools for 15 days in the State of Haryana in the winter spell. The

vacation period has been declared w.e.f. 25.12.2017 to 08.01.2018 on account of winter vacations. The schools were effectively closed from 23.12.2017 and they will remain closed upto 08.01.2018. The school will remain closed for 17 days in the State of Haryana as 23.12.2017 was Saturday and 24.12.2017 was Sunday. Effectively schools were closed from 23.12.2017. Copy of the orders dated 22.12.2017 is appended herewith as **Annexure P-4**.

7. That the order passed by the respondent no. 2 is not only incontrary to the provisions of the Haryana Education Rules, 2003 and the CBSE Affiliation Bye-Laws but also against the general ethics to ensure the betterment of the students. In State of Haryana due to the unfortunate instance occurred in the month of August & September the schools were remained closed for many days in different districts of the State of Haryana due to the unsavoury situation arises due to the arrest of Baba Ram Rahim. That period when the schools were remained closed puts the effect upon the smooth studies of the children thus, the respondent no. 2 should desist from closing the schools for such a long period when the season is very cosy and there is no harsh winter has started yet thus, there is no reason arises for closing the schools for such a long period by declaring the winter vacations for the students as the schools will not able to complete their academic session which is mandatory for them as per the Haryana Education Code and the CBSE Affiliation Bye-Laws but also they will not able to complete their curriculum on time. In nutshell the effect will be upon the academic achievements of the students reason being the examination for Class10th and 12th is going to be started in the month of February & March, 2018 and the students are yet to complete their syllabus which means that they are going to sit in the examination without getting their syllabus be fully covered.

8. That the Haryana Education Rules, 2003 which were notified by the State Government on 30.04.2003. According to these rules mandatory period of total school hours in a year were mentioned, as well as, the vacations and holidays to be followed in a school. According to the rules the school has to be open for not less than 220 days in a year. The school has to follow the total school hours of 1000 hours in a year. The rule 18 and 20 of the Rules 2003 clearly provides that:

#### "18. School hours sections 3 and 24 (2) (a) (b).

(1) The Director shall, by order, specify the time at which all schools, (including Private schools) shall commence and conclude the daily school hours and different timings may be specified for different seasons of the

year or for schools running in one shift or multiple shifts (irrespective of affiliation to any Education Board):

Provided that the total school hours in a year for the middle, secondary and senior secondary stage of education shall not, ordinarily, be less than 1000 hours:

Provided further that in addition to 1000 school hours, a teacher may not be required to devote more than 200 hours in a year for remedial or other teaching.

(2) The head of school with prior permission of District

Education Officer/District Primary Education Officer

concerned can change the time.

#### 20. Vacation and holidays. sections 3 and 24(2)(a)(b)

- (1) Save as otherwise provided in sub rule (1) of rule18, the total number of working days including examination days, for the Middle, Secondary and Senior Secondary stage of education shall not be less than 220 in a year.
- (2) Subject to the provision of sub-rule (1) of rule18, the following shall be the authorized holidays for recognized schools, namely:-
  - (a) all holidays notified by the Government for schools;
  - (b) summer vacation: 6 weeks as per instructions of the Director from time to time;
  - (c) festival: 6 days as per instructions of the Director from time to time;

- (d) winter vacation: 10 days as per instructions of the Director from time to time;
- (e) The local holidays: 4 days should be observed by the school with the approval of the Block Education Officer in case of Primary schools, Sub-Divisional Education Officer in case of Secondary Schools and District Education Officer, in case of Senior Secondary Schools.
- (3) In addition to the holidays referred to in sub-rule(2), leave may be granted to students preparing for the examinations of the Affiliating Board for such period as may be specified by that Board.

Provided that preparatory leave shall be given only when the head of school is satisfied that the courses of study have been completed at the school."

The rule 32 of the Haryana Education Rules, 2003 provides for the scheme of the management in which the duties, powers and responsibilities of the Head of the School has been clarified. The rule 32 (1) (viii) provides that the plan for the year's academic work has to be chalk out in advance, the rules also provides for ensuring the betterment of the students. The relevant extract of the Haryana School Education Rules, 2003 are appended herewith as **Annexure P-5**.

9. That the CBSE Affiliation Bye Laws also deals with the academic schedule to be followed by the respective

schools. The Chapter VI of the CBSE Bye-Laws deals with the duties, powers and responsibilities of the Head of the School. The rule 23 specifies the duties of the Head so that the children studying in the school could get best of the environment and they could able to attain the highest achievement in their life. The relevant provisions of the Rule 23 are reproduced below for the kind perusal of this Hon'ble court:

## "23. Head of the School- Duties, Powers and Responsibilities:

- i) Head of the School/Principal will be the ex-officio.
   Honorary Secretary of the School Managing
   Committee.
- ii) Will function as, the Head of the office of the school under his charge and carry out all administrative duties required of a head of office.
- iii) Be the drawing and disbursing officer for the employees of the school except that in the case of an unaided school, he may perform only such function, as drawing and disbursing officer as may be specified in the instructions issued by the Society.
- iv) Be responsible for the proper maintenance of accounts of the school, school records, service books of teachers, and such other registers,

- returns and statistics as may be specified by the Society/Board.
- v) Handle official correspondence relating to the school and furnish, within the specified dates, the returns and information required by the State Government/Board.
- vi) Make all payments (including salaries and allowances of teachers and other nonteaching staff) in time and according to the instructions governing such payment.
- vii) Ensure that the tuition fees, as levied, are realised and appropriately accounted for and duly appropriated for the purpose for which they were levied.
- viii) Make purchases of stores and other materials required for the school in accordance with the rules governing such purchases and enter all such stores in stock register and shall scrutinize the bills and make payments.
- ix) Conduct physical verification of school property and stock at least once a year and ensure the maintenance of stock registers neatly and accurately.
- x) Be responsible for proper utilization of the Pupils Fund.
- xi) Make satisfactory arrangements for the supply of good drinking water and provide other facilities for

the pupils and ensure that the school building, its fixtures and furniture, office equipment, lavatories, play grounds, school garden and other properties are properly and carefully maintained.

- xii) Supervise, guide and control the work of the teaching and non-teaching staff of the school.
- xiii) Be incharge of admission in the school, preparation of school timetable, allocation of duties and teaching load to the teachers, and shall provide necessary facilities to the teachers in the discharge of their duties and conduct of school examination in accordance with the instructions issued by the Government /Board from time to time; and he shall discharge these duties in consultation with his colleagues.
- xiv) Plan the year's academic work in advance in consultation with his colleagues and hold staff meeting at least once a month, review the work done during the month and assess the progress of the pupils.
- xv) Help and guide the teachers to promote their professional growth and actively encourage their participation in courses designed for in service education.
- xvi) Promote the initiative of the teachers for selfimprovement and encourage them to undertake experiments which are educationally sound.

- xvii) Supervise class room teaching and secure cooperation and coordination amongst teachers of the same subject areas as well as inter subject coordination.
- xviii) Arrange for special remedial teaching of the children belonging to the weaker sections of the community also of other children who need such remedial teaching.
- xix) Arrange for informal and non-class room teaching.
- xx) Plan and specify a regular time-table for the scrutiny of pupils written work and home assignment and ensure that the assessment and corrections are carried out timely and effectively.
- xxi) Make necessary arrangement for organising special instructions for the pupils according to their needs.
- xxii) Organise and coordinate various co-curricular activities through the house system or in such other effective ways as he may think fit.
- xxiii) Develop and organise the library resources and reading facilities in the school and ensure that the pupils and teachers have access to and use of books and journals of established value and usefulness.
- xxiv) Send regularly the progress reports of the students to their parents or guardians.

- ensure high standard of cleanliness and health habits, and arrange periodical medical examinations of the students and send medical reports to parents or guardians.
- xxvi) Devote at least twelve periods in a week to teaching of the pupils."

The Rule 31 & 32 also describes the working days, working hours and number of teaching periods. The rule 31 & 32 are also reproduced below for the kind perusal of this Hon'ble court:

#### "31. Working Days and Working Hours

- The working days and holidays will be as per State Government Schools or Kendriya Vidalayas.
- The working hours will be such as may be specified from time to time by the Principal. Normally the working hours will conform to the Kendriya Vidyalayas.
- 3. Working hours may be different for teaching and non-teaching staff as may be specified by the Principal.
- 4. As and when required an employee may be assigned any special duty even if it is to be done beyond the normal working hours in the interest of the school.

5. An employee is also required to conduct and organise co-curricular programmes and perform other duties even beyond the normal working hours.

#### 32. Number of Teaching periods:

- 1. Normally a teacher should be engaged as a whole-time employee except in special cases because of the nature of a subject where the work load does not justify a whole time teacher.
- 2. Every teacher shall devote in a year not less than 1200 hours to the teaching of students, out of which not more than 200 hours may be required to be devoted for the coaching in the school premises, of weak or gifted students, whether before or after the school hours.
- 3. Provided that if any teacher is required to devote more than 1200 hours to the teaching of students, extra remuneration shall be paid to him at such rate as may be determined, by the managing committee, for every hour in excess of 1200 hours devoted by him to the teaching of students.
- 4. In the case of an aided school, the extra remuneration referred to in sub-rule 32(3) shall be subject to the previous approval of the grant-inaid authority to qualify for aid of 95 per cent of such extra remuneration, and in the case of an unaided recognised school, such extra

remuneration may be recovered from the students at such proportionate rate as may be determined by the managing committee."

The copy of the CBSE Affiliation Bye-Laws dated 28.01.1998 is appended herewith as **Annexure P-6**.

10. That it is pertinent to mention here that the Punjab Government has declared the vacations in the School from 24.12.2017 to 01.01.2018 and their schools will be opened on 02.01.2018 whereas, the Delhi Government has given the exemption to the schools to not to give the vacations to the students studying in Class 9th to Class 12th, as well as, the schools are giving the flexibility to the private schools to declare the holidays according to their requirement whereas, the respondents have bent upon to declare the holidays for such a long spell of 17 days without any justification which could not only create the problem for students but for the school management also as they could not able to complete their curriculum when the examinations are going to start after few days when the schools are going to be opened on 09.01.2018. The petitioner association is before this Hon'ble court on behalf of their member schools not only to set aside the orders passed by the respondent no. 1 on 22.12.2017 (Annexure P-4) but also granting the flexibility to the private schools so that they could not

only able to complete their curriculum but also declare the holidays by considering the acute weather conditions as and when the situation be arises by getting the prior leave of the concerned District Education Officer of concerned Districts. There is a discrepancy in the schools situated in the State of Haryana which are affiliated with different boards. The schools affiliated with the Haryana Education Board and CBSE Board they are being forced to close their schools upto 08.01.2018 but the schools affiliated with the ICSE Board such as Kendriya Vidhyalaya's will going to be opened in the 1st week of January 2018, it shows the working of the respondents that they are not concerned with getting the curriculum of their students be completed on time so that they could also excelled as the students of other boards are doing.

- 11. That the following questions of law have been enumerated in the present writ petition for the kind perusal and adjudication by this Hon'ble court:
  - i. Whether the petitioner association is entitled to get the orders passed by respondent no. 2 on 22.12.2017 (Annexure P-4) be set aside which are in contrary to the provisions of the Haryana Education Rules, 2003 (Annexure P-5) and CBSE Affiliation Bye-Laws dated 28.01.1988 (Annexure P-6) as according to the orders passed

by the respondent no. 2 the member schools of the petitioner association will not able to complete their academic session as provided in the Rules and Affiliation Bye-Laws, as well as, their curriculum will not be able to completed on time before start of the Board Examination for 10<sup>th</sup> and 12<sup>th</sup> Classes?

- ii. Whether the member schools of the petitioner association could be granted the flexibility to run their schools till the weather conditions became harsh then they be permitted to close their schools for few days with the prior approval of the concerned DEOs/BEOs of the respective district. Till then the schools be allowed to remain open by setting aside the orders dated 22.12.2017 (Annexure P-4)?
- 12. That the petitioner association has left with no other efficacious remedy except to approach this Hon'ble court by way of filing the present writ petition to get the orders dated 22.12.2017 (Annexure P-4) be set aside by filing the present writ petition as no right of revision or appeal is available to them as per the Haryana Education Rules, 2003 (Annexure P-5) and CBSE Affiliation Bye-Laws dated 28.01.1988 (Annexure P-6).
- 13. That no such or similar petition has been filed by the petitioner before this Hon'ble court or before the Hon'ble

Supreme Court of India on the same cause of action except present petition.

#### **PRAYER CLAUSE**

- It is, therefore, respectfully prayed that a writ of certiorari may kindly be issued to quash the orders dated 22.12.2017 passed by the respondent 2 (Annexure P-4) vide which the respondent no. 2 ordered that all the schools situated in the State of Harvana will remain closed w.e.f. 25.12.2017 to 08.01.2018 (effectively the schools have already closed from 23.12.2017) on account of winter vacations as the orders passed by the respondent no. 2 is against the provision of Section 20 of the Haryana Education Rules, 2003 (Annexure P-5), as as, the proviso 23 of the CBSE (Annexure P-6);
- ii. A writ of certiorari may kindly be issued to the respondents to set aside the orders dated 22.12.2017 (Annexure P-4) as there is no acute winter is there and season is very good and a long vacation spell could not only hampered the completion of the syllabus of the students, as well as, the schools will not able to complete their mandatory academic session of 220 days in a year as per Section 20 of the Haryana Education Rules, 2003 (Annexure P-5);
- iii. A writ of mandamus may kindly be issued to the respondents to allow the private un-aided schools to

open their schools to complete their syllabus as very less time is available for completion of syllabus from Class 9<sup>th</sup> to Class 12<sup>th</sup> onwards reason being there is a board examination for Class 10<sup>th</sup> and Class 12<sup>th</sup> which will be start in the month of February and March, 2018 thus, the students will not able to complete their syllabus which will put the effect upon their academic achievements;

- iv. A writ of mandamus may kindly be issued to the respondents to grant the flexibility to the member schools of the petitioner association to close their schools as and when the acute winter starts and the school management will feel that the season is creating the impediment for the students in their smooth study thus, they will declare the holiday in their schools with the prior approval of the respective DEOs/BEOs of the District in the interest of justice.
- v. The petitioner may kindly be granted the exemption from serving the advance notice upon the respondents before filing the present writ petition before this Hon'ble Court.
- vi. The petitioner association may kindly be granted exemption from filing the certified copies of the Annexure P-1 to Annexure P-6, without appending the certified copies of the aforesaid annexure, as well as the permission be also granted to append the photocopies of the Annexure P-1 to P-6 alongwith this petition.
